1. Identity verification documents

Attach a copy of the following documents (1) or (2).

- (1) A copy of one of the following documents issued by a public institution with a face photo and the name and address written on it:

(Example) Individual Number Card (My Number Card), driver's license, passport, physical disability certificate, residence card with photo, special permanent resident certificate with photo, etc.

- (2) If there is no document with a photo, copies of two of the following documents:

(Example) Certificate of National Health Insurance card/health insurance card/Seamen's Insurance card/long-term care insurance, National Pension Handbook, receipt of local tax/national tax/social insurance premium/utility bill, etc.

2. Application for issuance of a marriage passport, etc.

The application for issuance of a marriage passport can be submitted either electronically or by mail.

- (1) Electronic application

Please submit an application on the special website.



- (2) Application by mail

Please send the Issuance Application Form (and Reissuance Application Form) for the Edogawa City Marriage Passport, etc., together with copies of identity verification documents, etc., for the applicant and spouse by mail in the designated application envelope.

3. Others

- (1) In the case of a same-sex partner relationship, please attach a copy of the same-sex partnership certificate, etc., under the Partnership Oath System of the local government.
- (2) In the case of a common-law marriage (for those who have a de facto marriage), the applicant and spouse must be in the same household and the relationship must be described as “husband (household head)” and “wife (not officially registered)” or “wife (household head)” and “husband (not officially registered)” on the Basic Resident Registration.
