Applying for the Edogawa Ward Private School Student School Lunch Subsidy Program

In 2023, Edogawa Ward announced the “Edogawa 50 Childrearing Plan.” Free school lunches for municipal elementary and middle school were implemented as part of this policy. At this time, as an expansion of these measures, Edogawa Ward is providing school lunch fees as a subsidy for students attending non-municipal schools within Edogawa Ward (including international schools).

[Eligibility (must meet both (1) and (2))]

- (1) Registered as a resident of Edogawa Ward (as of the 1st of each month)
(The student must have been born between April 2, 2010 and April 1, 2019.)

- (2) Not attending an Edogawa Ward municipal elementary or middle school

*Students who are attending schools where school lunch is free or who are already receiving subsidies (or assistance) for school lunch fees from local government organizations are excluded.

【Subsidy amount (comparable to the school lunch fees at Edogawa Ward municipal elementary and middle schools)】

- (1) Elementary school lower grades: 300 yen per meal, (2) Elementary school middle grades: 320 yen per meal

- (3) Elementary school upper grades: 340 yen per meal, (4) Middle school students: 385 yen per meal

*Subsidy amounts are calculated based on the amounts above multiplied by the number of days enrolled each month.

- (1) Application form (download from the Edogawa Ward website)
 - (Edogawa Ward Private School Student School Lunch Subsidy Application)
 - (2) A Copy of application (parent or guardian) identification document
(Driver's license, My Number Card, passport, etc.)
 - (3) If receiving assistance for a portion of the school lunch fees through another program, a copy of documents showing the amount
- Submit (1) and (2) ((3) only if applicable) via post or at the service counter (Edogawa Ward Office 4F, Counter #5: Board of Education Executive Office, School Affairs Division, Health and Lunch Services Subsection)

After submission, staff will confirm the application contents, and if the subsidy is approved, you will be sent an "Edogawa Ward Private School Student School Lunch Subsidy Application Approval Notification." Please fill in the required information on the enclosed "Edogawa Ward Private School Student School Lunch Subsidy Application and Wire Transfer Request Form," add the required documents, and mail these materials with the included return envelope. After confirming the contents, Edogawa Ward will wire the subsidy to the bank account indicated. Payments are scheduled for April 2026.

*Since the payment cannot be completed if the form is incomplete or required documents are not included, please confirm the contents before sending the return envelope. *An FAQ and additional information are available on the Edogawa Ward website.
